

# 3.1. Accounts for Payment

# 5. Recording Secretary Report

- Still chasing comp planner re points calculation div 3 Mens' match from Round 7 incomplete matches. Finals venues all done. Some players still missing requiring follow up. Recommend not to penalise junior players for non appearance of names on Results Vault.
- Recording Secretary contract renewal Adrian, Fiona and Mel to retrieve records of Recording Secretary contract to determine its expiry date this year or next? Fiona happy to train new person into the job in the coming year.

# 6. Sub Committee Reports

# 6.1. SAC Report

**Finals** - progressing well with very few issues. Plans for Grand Finals at Anembo & Mt Barker in place. Court allocations discussed for these matches.

**Port Elliott Tennis Club** - enquired about possibility of some senior teams joining HTA due to possible changes at their Association. Would Hills players be prepared to travel to the coast? Decided that many would see Port Elliott as being too far to travel. Juniors playing Seniors would physically not be able to get from a 10.30 match to a 1.00 match at Port Elliott. MC suggested that if Port Elliott TC were prepared to arrange home matches at another venue – eg no further than Strathalbyn or John Wesley, this may be a possibility.

**Summertown Courts** – concerns raised from frustrated players about the state of Summertown courts. Summertown indicated informally that they are very keen to upgrade, but feel that funding has always gone elsewhere whenever they have applied for it. Discussion point for AGM. HTA wishes to support Summertown in upgrading their courts - would be good to have a plan from them as to how this is going to be addressed in the near future. Perhaps use alternate venue until courts are upgraded.

**EDTA Participation of Hills Players** – Stirling have asked the HTA to review the current rules regarding EDTA participation. A rep will attend an MC meeting in the near future to put forward a proposal for change. Concerns also been raised at Junior level, particularly with recent Hills Winter nominations being quite low. Clubs need to adhere to the current requirement that ANY team intending to participate in EDTA must gain HTA approval. Rules of Match and Play to be clarified/adjusted next season. To be discussed next meeting.

#### 6.2. JAC Report

**Junior Finals**: Going well, thanks to Fiona for loading venues onto Results Vault. Issues arising (now resolved):

- Scoresheet score filled in by players which ended in disputed result 1 game draw incident. Outcome have asked team managers to complete scores entry on the scoresheet and have both scoresheets next to each other.
- Names loaded into vault...fixed by Fiona
- Wording of Rule 5.2.1 (b) "Doubles The number 1 singles player MUST play in the first (top) double". Occasionally number 1 singles player doesn't play doubles. Jo reported similar query at senior level rule change required to clarify.
- Code of conduct breach addressed by JAC. Outcome warning and written apology from adult to player involved.
- Complaint of behaviour of Div 9 junior. Littlehampton Junior co-ordinator has spoken to father and player and confident it will be curbed.
- Numerous permits Ok'd by JAC due to injury and absence work on whether team is strengthened or not for outcome.
- As Aldgate have 3 junior teams playing at Anembo this week, have asked they provide supervisor and scheduled matches all together on courts 7-12.
- Asked Mt Barker for info/guidelines re Grand Finals (8.30am 2 teams playing here) due to Show Day inform opposition teams when received.
- Pennants/medallions to be given to hosting clubs this week. Ian absent on GF day.

**Compass Draw** - 14 and Under cancelled due to heat policy. 12 and Under team made semi-finals in main draw, the other won the consolation draw (1<sup>st</sup> round loser).

**Foundation Cup trials** – Sunday 3<sup>rd</sup> May (due to school holidays and court availability). 10, 13 and 15 and under trials. Anthony Klatt to organise for online entry to Myles.

**Winter Pennant** – approximately 40 players registered at this stage (closing soon) so Hills will have at least 8 teams competing in Southern Districts.
